

1. The term “Company” in these Terms and Conditions refers to LeoPrime. The word “We” also refers to the Company, LeoPrime.
2. The term “Agreement” refers to anything laid out in these Terms and Conditions
3. The Bonus refers to the Welcome Bonus and can sometimes be just referred to as the “Bonus” in these Terms and Conditions.
4. Client agrees that by participating in this promotion, that you will be bound by these terms (“Welcome Bonus Terms”) as well as the Terms and Conditions that apply to your trading account with LeoPrime. Capitalised terms and expressions used in these Promotion Terms shall have the same meaning as in Terms and Conditions, unless specified otherwise.
5. LeoPrime offers a 25% Welcome Bonus.
6. This Welcome Bonus can be obtained by every new client and existing clients for their first deposit (the minimum deposit required for claiming the Bonus is USD\$200).
7. This Bonus will be valid only 30 days from the initial date the Bonus is claimed on.
8. The Bonus will be credited out automatically after the validity ends.
9. This Bonus is not withdrawable.
10. The Bonus can be obtained for one trading account only.
11. The maximum amount of Bonus for a profile is USD\$250.
12. This Bonus can be claimed only for Live Classic trading account.
13. Internal transfers between the accounts or commissions paid by LeoPrime will not be considered as a first deposit. The application for the Bonus cannot be accepted for a deposit made by internal transfer or any commission paid by LeoPrime.
14. The 25% Bonus offer cannot be claimed to the accounts if any other bonuses have been awarded before.
15. The Bonus will be deducted if the client submits a withdrawal request or tries an internal transfer between accounts before the validity of this Bonus ends. For example: If the client deposits USD\$1,000 and receives the 25% Bonus. Then if the client trades with the deposited funds and the Bonus and he/she earns a profit of USD\$500. If the

client submits a withdrawal request or tries an Internal Transfer before the expiry date, or on the expiry date of the Bonus period, then LeoPrime has the sole responsibility to deduct the Bonus amount immediately.

16. Any withdrawals/internal transfer requests placed by the client within 30 days (i.e. the Bonus validity period) will be processed by the Company, but the Bonus credited to his/her account will be removed.
17. In case of fraudulent activities, such as if the Bonus is received by one client for several accounts, multidirectional orders, or there are many meaningless lots are generated etc., then the Company reserves the right to cancel the account(s), the Bonus amount and the profit gained with this Bonus without notice.
18. In case of any relation is detected between accounts (i.e. IP address, or if the different devices are using the same IP address etc.) as well as the use of services that provide anonymity (i.e. VPS, Proxy, VPN, networks such as Tor, VPS etc.), the Company reserves the right to, after investigation, cancel the Welcome Bonus and the earned profit.
19. Using unlicensed copies of Windows can also lead to the cancellation of the Bonus, since the analysis algorithm for the account's affiliation detection can use the operating system license data. The Company reserves the right not to disclose ways to detect crossings accounts activities, as well as any fraudulent actions.
20. The Company reserves the right, in our sole discretion, to immediately disqualify any individual violates or attempts to violate in the operation of this Bonus are reasonably suspected of any form of manipulation on their trading or account with Leo Prime Services Limited.
21. The Company reserves the right to alter, amend or terminate this Bonus, or any aspect, part or feature of it, at any time, without prior notice to the client. We may make changes to these Bonus terms and the Company will post the modified terms on the Leo Prime Services Limited website. We advise you to revisit these Bonus Terms and Conditions regularly.
22. Price feed errors, internet interruptions, and connectivity delays sometimes create a situation where the prices displayed on the Trading Platform do not actually reflect the market rates. Trading strategies aimed at exploiting such errors in prices (or) concluding trades at off-market prices or taking advantage of these internet delays are not permissible on the trading account.

23. If the Company, with a valid reason with proof, suspects that the client, based on his/her trading strategy or other behaviors, deliberately and/or systematically exploited or attempted to exploit such errors in prices and/or off-market prices, then the Company is entitled to take one or more of the following counter measures:

- a) Restrict or block access to the trading platform,
- b) Terminate this Agreement immediately,
- c) Close the client's account immediately,
- d) Remove any of the client's trades,
- e) Take legal action for any losses suffered by the Company.

24. The Company will not be responsible or liable for any loss, damages or costs suffered by you relating to or in connection with your participation in this Bonus or in accepting any bonus, rewards or prizes under this Bonus.

25. The official language of the Agreement is British English. In case of variant readings of translated versions of the Agreement, the Agreement in English is only considered as a prior reference standard.
